# लाहुल घाटी में फंसे 24 हजार कार्टन सेब

कुल्लू, ९ नवंबर (जनसत्ता)।

लगातार हो रही बर्फबारी से लाहुल घाटी के लोगों की दिक्कत बढ़ गई है। रोहतांग दरें में ढाई फीट बर्फ पड़ने से दर्रा बन्द हो गया है। रोहतांग बंद होने से लाहुल के बागवानों के लगभग 24 हजार कार्टन सेब लाहुल में फंस गए है। हालांकि सेब का सीजन समस्त घाटी में चल रहा है लेकिन लाहुल के उदयपुर, जहालमा, गोरमा, शांशा, जोबरंग, कीर्तिंग, लौट, ठोलंग, तांदी, गोशाल और बिलिंग में सेब के कार्टन अधिक मात्रा में फंसे हुए हैं। पिछले साल भी बर्फबारी ने बागवानों की उम्मीदों पर पानी फेर दिया था और इस साल भी लगभग 60 ट्रक सेब बर्फबारी से लाहुल घाटी में फंस गए है। बर्फबारी ने बागवानों की नींद उड़ा दी है।

लाहुल घाटी के बागवान उदयपुर से अनिल ठाकुर, जाहलमा से जगदीश, शांशा से सोनम, ठोलंग से प्रेम, तांदी से अजित और बिलिंग से सोमदेव ने बताया कि घाटी में अभी 24 हजार सेब के कार्टन फंसे हुए है। उन्होंने कहा कि पिछले साल भी भारी नुकसान हुआ है और इस साल भी बर्फबारी उन पर भारी पड़ी है। उन्होंने कहा की रोहतांग में लगभग 3 फीट बर्फ गिर चुकी है जिससे रोहतांग बंद हो गया है।
