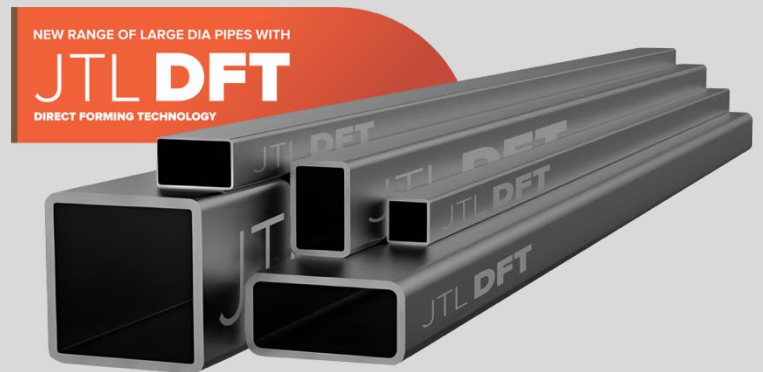

(26.5%YoY, 32.4% QoQ)

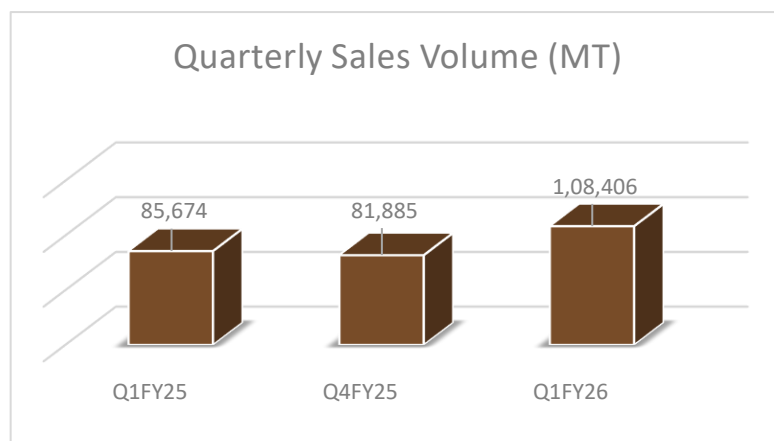

Business Sales Volume Update:
